Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of FIVE HUNDRED FORTY-FOUR THOUSAND EIGHT HUNDRED TWO PESOS ONLY (Pph544,802.00) or such other sums as may be ascertained, SCIENCESTAR CORPORATION agrees to provide the goods and services and to remedy defects therein in conformity with all respects of the provisions of the Contract in accordance with its Bid.
- 4. The CATANDUANES STATE UNIVERSITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
