



## Invitation to Bid for the

### REPAIR/REHABILITATION/RETROFITTING/REPLACEMENT OF FOOD LABORATORY BUILDING

1. The *Catanduanes State University*, through the *General Appropriations Act FY 2021* intends to apply the sum of *Nine Million Nine Hundred Thousand Pesos (Php9,900,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for ***Repair/Rehabilitation/Retrofitting/Replacement of Food Laboratory Building***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Catanduanes State University* now invites bids for:

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Catanduanes State University Bids and Awards Committee (BAC) Secretariat* and inspect the Bidding Documents at the address given below from *9:00a.m. to 4:00p.m. (Mondays-Fridays)*.
5. A complete set of Bidding Documents may be acquired by interested bidders (with Letter of Intent) on **04 February 2021 (Thursday) to 23 February 2021 (Tuesday)** from **8:30AM to 4:30PM** from the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php10,000.00)**. Payment shall be made directly to the CatSU Cashiering Services. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means*.
6. The *Catanduanes State University* will hold a Pre-Bid Conference on **February 11, 2021 (Thursday), 2:00pm** at the *Audio Visual Room (AVR), 3<sup>rd</sup> Floor, Administration Building, Catanduanes State University* which shall be open to prospective bidders.

8. Bids must be duly received by the BAC Secretariat through *manual submission* at the office address as indicated below on or before **February 24, 2021 (Wednesday) at 9:15am**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
10. Bid opening shall be on **February 24, 2021 (Wednesday) at 9:30am** at the *Audio Visual Room (AVR), 3<sup>rd</sup> Floor, Administration Building, Catanduanes State University, Virac, Catanduanes*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

Only representative/s of the bidder with the prescribed Authorization Letter/Special Power of Attorney shall be allowed to participate in the procurement activities of the stated project.


